The Surrey Vintage Vehicle Society (SVVS) is committed to respecting your privacy.

How we collect information: We collect information you provide to us by filling in membership application and/or renewal forms.

How we use information: Personal data will be used for the administration of the SVVS. We will not pass your personal data to any third party organisation, except to comply with any court order, law or legal process, including to respond to any government or regulatory request.

Accessing and Correcting Your Data: You have the right to access and update your personal data held by the SVVS by writing to the Membership Secretary or Vehicle Registrar. Such data will be supplied without delay and at the latest within one month of receipt of the request. Data Corrections submitted to the SVVS will be processed within one month of receipt.

Erasure or Restriction of Processing of Data: You may request that your personal data is erased from current SVVS records by terminating your membership in writing to the membership secretary. You may restrict the further processing of such information by withdrawing your consent, i.e. to your personal information being included in the vehicle register.

Your Right to Object: You have the right to object if you believe the SVVS is using your personal data for any purpose other than as stated above, to include profiling, direct marketing or processing for purposes of scientific/historical research and statistics.

Retaining your Data: Your personal data will only be retained for as long as is necessary for the administration of the SVVS. In the event of you not renewing your membership, your data will be erased from current records after 3 calendar months of the annual membership subscription renewal date.
